### **Participation Instructions:**

Incomplete forms will not be accepted. The participant will receive confirmation of receipt of the redemption form via e-mail within 10 working days. - (b) Software license must be upgraded between **1st Jun – 30th Jun 2024.**

### **Eligibility Requirements:**
